

Organizational structure

- Hierarchical organizational trees and other structure types
- Designation of managers of organizational units
- Synchronization from its source in the HR
- MidPoint can be the source itself

Audit

- Verification of important actions in the system
- Recording the most important interactions in the system
- Recording the interactions on "business" level
- Machine-processable audit record, designed to be pluggable




Entitlement management

- Assignment of roles to users and their management
- Granting, resolving or enforcing entitlements
- Order between users, roles and resources
- Increase of security level
